NOTICE INVITING TENDERS (Reinvitation-I)

Sealed tenders are invited in two parts on behalf of the President of India by the under mentioned authority of Raja Ramanna Centre for Advanced Technology, P.O.: RRCAT, Indore (M.P.) - 452 013 from the eligible contractors for the works detailed below:

PRE-BID MEETINGS can be held up to 11.01.2011 with prior appointment with office of Head , C & S Division, RRCAT, Indore & bidders may seek technical clarifications, if any. Minutes of pre-bid meeting based on discussed issues shall be circulated to all the bidders and shall be treated as condition of contract.

The Earnest Money Deposit mentioned above shall be submitted in the form of Fixed Deposit Receipt/Crossed Demand Draft of a scheduled bank guaranteed by the Reserve Bank of India, in favour of Pay and Accounts Officer, Raja Ramanna Centre for Advanced Technology PO: RRCAT, Indore – 452 013 (MP). Tenders not accompanied by EMD in the prescribed form shall be summarily rejected.

Tenderers shall submit the tender as follows:-

The first envelope marked as 'A' shall contain requisite EMD in the appropriate form along with qualifying documents as mentioned in sub clauses a to h. Second envelope marked as 'B' shall include technical tender document part I i.e. technical bid duly signed. The third envelope marked as 'C' shall contain only financial bid i.e. Part II (Schedule of quantities), duly filled in, Both the parts i.e. Part- I (Technical) & II (Financial) shall be without any further quarry/condition. **No modification/revision in part I (Technical) & the rates quoted in part II (Financial) shall be allowed after submission**. Envelope A containing EMD & envelope B containing part-I (Technical) shall be opened on the date of submission i.e. on **19.01.2011**.

The date of opening of Part-II i.e. **Financial** bid contained in the envelope marked as 'C' shall be communicated separately. The Part II i.e. Financial bids shall be opened after judging the technical suitability of the bidders. The suitability of the bidders shall be judged by the technical committee of experts formed by RRCAT as per the procedure stipulated in the tender documents. The technical committee may also inspect the work of bidders to ascertain their suitability. The financial bids of such bidders who are considered suitable by the technical committee only be opened. No claim or representation in this regard shall be entertained by the department.

Sale of tenders: Tender documents for the work as listed above can be purchased by the bidder(s) on any working day during the sale period between 10.00 Hrs. to 16.00 Hrs. from the office of the Head, C & S Division, RRCAT.

Eligibility criteria for participation in the tender:-

- a. Proof of registration in appropriate class with Semi Government / Government organizations like Railways, PWD, CPWD, MES etc. in appropriate class and/or proof of having experience in carrying out similar type of works.
- b. Latest **solvency** certificate of value not less than 40 % of the stipulated estimated cost issued by any scheduled bank. The solvency certificate shall not be older than 12 months from the date of submission of tender of concerned work.
- c. List of construction plants, machinery & infrastructure facilities to ensure timely completion of the work.
- d. List containing details of technical manpower.
- e. **List of works in hand & similar works carried out by them for the last seven years indicating (i) Agency for whom executed, (ii) Value of work,(iii) Completion time (Stipulated & Actual) or present status of the work.** (Copies of work order with schedule of quantities to be enclosed with the application.)
- f. Performance certificates of the completed work(s), issued by the client.
- g. Proof indicating average annual turnover of the tenderer not less than 30 % of the stipulated estimated cost during **last five years** as reflected in the profit and loss statement of **five years** out of which loss has not been incurred for more than **two years**.
- h) Experience of having successfully completed similar works of following value during the last seven years **ending on 31.10.2010**.
 - . **3 similar works completed each costing not less than 66 Lakhs OR**
 - . **2 similar works completed each costing not less than 99 Lakhs OR**
 - . **1 similar work completed costing not less than 132 Lakhs.**

NOTE:-

(1) The value of executed works shall be brought to the current costing level by enhancing the actual value of work at simple rate of 7 % per annum; calculated from the date of completion to the last date of receipt of applications for tender.

(2) IF ANY INFORMATION FURNISHED by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering / taking up works in RRCAT

For purchase or submission of tender documents, contractor or his authorized representative shall bring identity card such as PAN card or driving license issued by competent Govt. officer or photo identity card issued by Election commission.

Submission & opening of tenders:-

The EMD shall be kept in the envelope marked as 'A'. The envelope 'B' shall contain Part-I (Technical) only and the envelope marked as 'C' shall contain Part-II (Financial) duly filled, signed & sealed by the bidder. All these three envelopes shall be kept in the fourth envelope which shall also be sealed. Each envelope shall be superscribed with the name of work, tender number and A, B or C as applicable.

Tenders shall be received up to 15.00 hrs. on the stipulated date of submission indicated in the table and envelope A & B shall be opened at 15.30 hrs. on the same day i.e. 19.01.2011.
