**PRE-BID MEETING** can be held up-to **01.08.2011** with prior appointment of Head, C&S Division, in his office at RRCAT, Indore. Bidders who like to be present may seek technical clarifications, Minutes of meeting based on discussed issues shall be circulated to all the attending bidders and shall be treated as condition of contract.

The tender should be submitted in two parts i.e. Part-I (Technical) and Part-II (Financial) in two separate sealed covers by due date before 1500 hrs. Part I - Technical (i.e. envelopes A&B) s opened at 1530 hrs. on the date of submission of tenders i.e. **on 03.08.2011**.

The Earnest Money Deposit mentioned above shall be submitted in the form of fixed deposit receipt/crossed demand draft of a scheduled bank guaranteed by the Reserve Bank of India, in fa Pay and Accounts Officer, Raja Ramanna Centre for Advanced Technology PO: CAT, Indore – 452 013 (MP). Tenders not accompanied by EMD in the prescribed form shall be summarily reject

**Tenderers shall submit the tender as follows:-**

The first envelope marked as 'A' shall contain requisite EMD in the appropriate form alongwith qualifying documents as mentioned in sub clauses a to h. Second envelope marked as 'B' shall technical tender document part I i.e. from Section-I to Section-VII except financial bid. The third envelope marked as 'C' shall contain only financial bid i.e. Section VIII – Schedule 'B' (Sche Quantities) duly filled in, **without any condition**.

The date of opening of Part-II i.e. **Financial** bid contained in the envelope marked as 'C' shall be communicated separately. The Part II i.e. Financial bids shall be opened after judging the te suitability of the bidders. The suitability of the bidders shall be judged by the technical committee of experts formed by RRCAT as per the procedure stipulated in the tender documents. The te committee may also inspect the work of bidders to ascertain their suitability. The financial bids of such bidders who are considered suitable by the technical committee only be opened. No c representation in this regard shall be entertained by the department.

**Sale of tenders:** Tender documents for the work as listed above can be purchased by the bidder(s) on any working day during the sale period between 10.00 Hrs. to 16.00 Hrs. from the office Chief Engineer, RRCAT.

**Eligibility criteria for participation in the tender:**

- a. Proof of registration in appropriate class with Semi Government / Government organizations like Railways, PWD, CPWD, MES etc. in appropriate class and/or proof of having experience carrying out similar type of works.
- b. Latest solvency certificate of value not less than 40 % of the stipulated estimated cost issued by any scheduled bank. The solvency certificate shall not be older than 12 months from the submission of tender of concerned work.
- c. List of construction plants, machinery & infrastructure facilities to ensure timely completion of the work.
- d. List containing details of technical manpower.
- e. List of works in hand and similar works carried out by them for the last seven years indicating (i) the Agency for whom executed (ii) Value of work (iii) Completion time (Stipulated & Actual) present status of the work. (Copies of work order with schedule of quantities to be enclosed with the application.)
- f. Performance certificates of the completed work(s), issued by the client.
- g. Proof indicating average annual turnover of the tenderer not less than 30 % of the stipulated estimated cost during last five years as reflected in the profit and loss statement of five years of which loss has not been incurred for more than two years.
- h) Experience of having successfully completed similar works of following value during the last seven years.
  - . 3 similar works completed each costing not less than 40% of the stipulated estimated cost OR
  - . 2 similar works completed each costing not less than 60% of the stipulated estimated cost OR
  - . 1 similar work completed costing not less than 80% of the stipulated estimated cost.

**NOTE:-**

- 1) The value of executed works shall be brought to the current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to the last date of receipt of applications for tender.
- 2) If any information furnished by the applicant is found to be incorrect at a later stage, they shall be liable to be debarred from tendering/taking up works in RRCAT.
- 3) Tender document shall not be sent by post.

For purchase or submission of tender documents, contractor or his authorized representative shall bring identity card such as PAN card or driving license issued by competent Govt. or photo identity card issued by Election commission.

**Submission & opening of tenders:**

The EMD shall be kept in the envelope marked as 'A'. The envelope 'B' shall contain Part-I (Technical) only and the envelope marked as 'C' shall contain Part-II (Financial) duly filled, signed and sealed by the bidder. All these three envelopes shall be kept in the fourth envelope which shall also be sealed. Each envelope shall be superscribed with the name of work, tender number and C as applicable. **Part-I (Technical bid) shall be opened on 03.08.2011 @ 1530 hrs.**

**Tenders shall be received up to 15.00 hrs. on the stipulated date of submission indicated in the table and envelopes 'A' & 'B' shall be opened at 15.30 Hrs. on the same day.**
